

Napa Silverados Baseball Club Catering & Concessions Agreement

THIS AGREEMENT is entered into this 29th day of May, 2018 by and between: NVC District Auxiliary Services Organization (DAS) and Napa Silverados, an independent league professional baseball team.

DAS will satisfy this agreement for Catering and Concessions as an enterprise activity of the Hospitality, Culinary & Tourism Management (HCTM) Program.

DAS, through HCTM, will purchase, store, prepare, and cook the food for the concessions at the NVC baseball field that is rented by the Napa Silverados. On game days, the food will be prepared, cooked, and transported to the concession area by the field. HCTM will also provide food service staff and a supervisor, with a ServSafe Manager certification, to oversee the service of the concessions. HCTM will conduct cooking contests with Napa Valley College students to generate new ideas for items to serve during game days.

HCTM will operate a concessions stand and/or provide a food truck for food service.

HCTM may work with other sponsors to feature menu items that are themed.

Services will be provided at each of the Napa Silverados home games as indicated on the game schedule dated 2/14/18 (attached).

HCTM will work with the Silverados to establish levels of service, menu prices, and selection at the concessions stand.

This Agreement shall be effective as of the date that it is signed by both Parties to this agreement.

This Agreement shall be effective for the 2018 regular season.

Either party may terminate this Agreement for its own convenience or for no reason by providing 30-day written notice to the other party.

INDEMNIFICATION

The Napa Silverados and the undersigned agree to defend, indemnify, and hold harmless the Napa Valley Community College District and DAS, and their respective Boards of Trustees and Directors, officers, agents, employees, volunteers, and students, individually, or collectively, from and against all damages, liability, costs, losses, claims, demands, suits, actions, payments, judgments, or causes of action, including legal costs and attorneys' fees, arising out of or in any way related to this Agreement, including but not limited to, liability arising from personal or bodily injuries, property damage, advertising, security or police actions or omissions, and inadequate permitting.
