PAYMENT AND REFUND POLICIES:

- Students are required to pay for classes within 14 days of registration. If you fail to pay all class-related fees within the 14 days of registration, you may be dropped for non-payment.
- Drop with refund policy is applicable only to the \$46/unit enrollment fee. Other NVC fees are non-refundable after classes begin. See the NVC Fees and Refunds page online.
- Refunds for international and non-resident tuition are 100% for the first two weeks, 50% on the 3rd week and 25% the fourth week.
