Hospitality, Culinary and Tourism Management increased by 120%. The increase in enrollment resulted from a 45% increase in section offerings (2020-2021 to 2021-2022) and working with industry partners to recruit students into the pipeline.

In-person offerings in 2020-2021 focused on courses within career technical education and those with a lab requirement.
