In addition, current policy requires those who have already been trained to refresh every two years in order to be compliant with the policy. The training includes a comprehensive review of federal and state laws, principles of diversity, equity, inclusivity, and accessibility (DEIA) that are the basis of our recruitment practice, and best practice tips and suggestions to help selection committees manage the successful screening, interview, and evaluation of job candidates.

First Amendment Auditors

In recent years, government agencies, including colleges, have seen a rise in visits from citizens recording staff under the protections of the First Amendment. These individuals, known as First Amendment Auditors, aim to observe college operations and interactions to see if constitutional rights are upheld. While auditors might have good intentions to promote transparency and accountability, their unconventional tactics, like filming staff and refusing to identify themselves, can often create confusion and even conflict. This course will provide a brief overview of the First Amendment Auditor movement along with associated laws. We will also discuss best practices during these interactions to protect and maintain a positive educational environment while respecting civil liberties.
