## Title IX Basics

Title IX is a federal law that prohibits sex-based discrimination in educational settings that receive federal funding. In 2024, the Biden administration released substantial updates to the regulations that guide how we handle Title IX cases and expanded sex-based discrimination to include genderidentity and sexual orientation. We will discuss your rights as well as your legal responsibilities to our students. You will learn what types of behaviors must be reported and how to report them, in addition to what the Title IX and Civil Rights office can offer to students, faculty, and staff.
